### **PARTNERSHIP NEWS:**



This month's Partnership's meeting was held in the Community Centre at 6.30 p.m. on Wednesday, 20<sup>th</sup> March, 2019.

Under 'Matters Arising' Brenda SURTEES, Secretary of the Community Centre, informed the meeting as a result of concerns about the lighting outside the main entrance of the Centre, a new light had been installed which should help to alleviate the problem of people not being able to see the kerb.

Ms Rebecca HAYNES from the Alzheimer's Friendly Village gave a brief outline of how we could make Leadgate a 'Dementia Friendly Village'. The first step is to set up a steering group which, to start with, would set up two actions. If anyone is interested in joining this group, Rebecca's details are as follows:

Rebecca said she is available for advice, etc. to anyone with dementia or if you know any with dementia who needs help. She also informed the meeting Medomsley Village has now become a 'Dementia Friendly Village'.

**PLAY AREA:** The land problem for this area which is situated at the bottom of Watling Street, is still be sorted out. A sub group of the Partnership has been set up and with the first of any monies obtained, it is proposed to replace some of the present equipment. The Banks Mining Community Fund is now available - one of the requirements is three (3) estimates.

It has been suggested that directional signs should be obtained for the village which would inform visitors and also those passing through, what amenities are available. Two sites were proposed one at the Doctors' Surgery and the other on what has become known as 'the Gap Site'. Before anything is done, the question of planning permission has to be consider, will it be required from Durham County Council and Sustrans? The next consideration would be cost.

# **COUNCILLORS' REPORTS:**



<u>PLAY PARK (PONT/WATLING</u>: The project to re-develop/extend the current play park requires an extended lease (e.g. 25 years) to be agreed between Durham County Council (DCC) and the current landowner before any extension could be considered. DCC Estates/DCC Legal are to have discussions with the landowner's representative to progress this issue – landowner is sympathetic to the needs of the community to develop the play park: various aspects of funding support need to be accessed to implement the equipment for this extension.

SHOTLEY BRIDGE COMMUNITY HOSPITAL: Pubic engagement meetings are to be scheduled in the next eight (8) weeks (in and around the Derwentside area) to consider and review the proposals, options and extent of service delivery for the new community hospital, e.g. number of rehabilitation (step down beds): urgent care: diagnosis (Ultra Sound/X ray): chemotherapy. The options to provide an operating theatre and Endoscopy service are not being recommended for the new Community Hospital, mainly because of the lack of clinical specialists who will be based at Acute Hospitals (University Hospital North Durham and Darlington). The location for the new Community Hospital has yet to be determined.

**CHRISTMAS TREE**: A permanent living Christmas tree (funded by Councillors) is to be planted at the 'Gap Site' (within a protective steel enclosure) in the few weeks.

**EDEN MINERS' CENTRE**: A new 'tenant/hirer' (Kerry Kirkwood School of Dance) is to commence using the upper part of the building (main hall), commencing 2<sup>nd</sup> April, 2019. New and additional trustees have been appointed to the Trustee Board: the refurbishment work (financed by local councillors) is almost complete.

**BRADLEY OPEN CAST**: A proposal for an extension (to mine an additional 100,000 tons of prime coal) to the current open cast site at West Bradley (the fields opposite the 'Jolly Drovers') is to be submitted by the Banks Group – this will require a full planning application heard by DCC Strategic Planning Committee.

/Banks propose

Banks propose that the extension (if granted) could be completed within the current given timescales (completion before August,2021) and they state that they are willing to enter into a legally binding agreement not to open cast to the north or east of the existing site and an additional £48,000.00 will be added to the Community Fund.

**PARKING – FRONT STREET**: The creation of laybys (opposite some of the businesses in Front Street) will necessitate the re-location of a BT cable and BT has quoted the re-location cost to be circa. £55,000 – this cost cannot be considered on top of the layby's cost at £19,000. Therefore an alternative option of creating a reduced kerb height and installing a hard standing area (tarmac or block paving) will be considered once the costs have been provided.

The next meeting of the Partnership will be on Wednesday, 17<sup>th</sup> April, 2019 at 6.30 p.m., in the Community Centre and those people who are interested in having Leadgate become a 'Dementia Friendly Village' are asked to attend.



#### **POLICE REPORT**






